SEALED BIDS, electronic or paper, addressed to the City Clerk of the City of Minden, will be received in the City Clerk's office located in Minden City Hall, 520 Broadway Street, Minden, Louisiana, until **2:00 P.M., Tuesday, March 31, 2026**, for the **Industrial Drive Rehabilitation @ IA Hwy 531** project.

The bids will be publicly opened and read aloud at 2:00 p.m. in the Minden City Hall Cypress Room located at 520 Broadway Street, Minden, Louisiana.

In accordance with the Louisiana Public Bid Law, RS:38:2212 Act No. 590, 2008, Contractors shall be provided the option to submit bids for Public Work projects through either a secure electronic interactive system or by submitting a paper bid. Electronic bids may be submitted at www.BidExpress.com. If bidding online, all interested parties must register with Bid Express. If bidders encounter problems accessing Bid Express, please contact Bid Express at 999-352-2439.

Specifications, Plans, and Contract Documents shall be obtained from the office of the Engineer, 700 Ogilvie Street Suite A, Bossier City, LA 71111 for **\$50.00**, made out to Waggoner Engineering. A **Mandatory Pre-Bid Conference** is scheduled for **10:00 A.M., Tuesday, March 24, 2026**, at the Minden Public Works Control Center at 115 Horton Street, Minden, LA 71055. All questions shall be submitted by 2:00 P.M., Tuesday, March 24, 2026.

Bids shall be submitted on the official Bid Form furnished with the bid package and those submitted otherwise will not be considered or accepted. It shall be the Bidder's responsibility to make inquiry as to any Addenda issued.

The lowest responsive Bidder will be required to submit the Attestation Form (Section 00420) and the Non-Collusive and Non-Solicitation Affidavit (Section 00480) within ten days after the bid opening. These documents can be mailed, faxed, or e-mailed.

Each proposal must be accompanied by a bid security, which may be a certified check, cashier's check, or bid bond, for an amount not less than 5% of the amount of the bid, made payable to the City of Minden, Louisiana. An acceptable performance/payment bond equal to 100% of the contract price will be required of the successful bidder.

The successful bidder will agree to commence the work under this contract on or before a date to be specified in the Notice to Proceed and fully complete the project within **One Hundred Thirty (130) working days**. Bidders will pay liquidated damages, the sum of **\$1000** for each consecutive calendar day thereafter.

On any bids submitted in the amount of \$50,000 or more, the Contractor shall be licensed under Louisiana Revised Statutes 37:2150-2163 and show his license number on the bid and on the envelope in which it is submitted. Any Subcontractors being Electrical, Mechanical, or Plumbing (plumbers bidding Mechanical
